What?

How?

Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. • Our affiliates include companies with an Associated name; financial companies such as Kellogg Asset Management, LLC
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. • Associated does not share with nonaffiliates so they can market to you
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. • Our joint marketing partners include credit card companies, investment firms and insurance companies
